Cub Crafters, Inc. Considers Compliance Mandatory March 13, 2006
The parts of this Service Bulletin that change the Type Design of the aircraft have been approved by the FAA.

SUBJECT: Fuel Tanks

MODELS AFFECTED: CC18-180 serial numbers 0002, 0004, 0005, 0007, 0008, 0009, and

0011.

COMPLIANCE TIME: Part A As part of a daily inspection, prior to flight

Part B On the next regularly scheduled inspection of the aircraft or before the aircraft reaches 200 hrs or if there is any evidence of fuel

leaks from the wing fuel tanks.

PURPOSE: Cub Crafters, Inc. has determined that the application of coating

inside the fuel tank will improve the sealing of the tank and ensure that fuel will not weep from seams or rivet areas. A new set of fuel tanks in which this process has been carried out will be supplied to

replace the original tanks that are installed on the aircraft.

INSTRUCTIONS: PART A DAILY INSPECTION

1. When performing the first pre-flight inspection of the day, carefully observe the area under the wing where the fuel tanks are located.

2. If blue fuel stains are observed, contact Cub Crafters, Inc. immediately. The aircraft may not be operated in this condition.

PART B FUEL TANK REPLACEMENT

- 1. Safety the aircraft. Drain fuel from the fuel tanks installed on the aircraft. This may be accomplished either through the drain valve on each tank or by using the strainer on the gascolator just forward of the engine firewall.
- 2. Remove the fuel tank covers.
- 3. By following the procedure described in Chapter 28-00 Section 3.A(1) of the CC18 Aircraft Maintenance Manual, remove both fuel tanks (P/N TC7100-001 for LH and -002 for RH).
- 4. Visually inspect the new fuel tanks (P/N TC7100-001 for LH and -002 for RH) that are supplied by Cub Crafters for any damage caused during shipping.
- 5. Install the new fuel tanks in accordance with Chapter 28-00 Section 3.A(4) of the Aircraft Maintenance Manual.
- 6. Install and secure the fuel tank covers.
- 7. Record this modification in the aircraft's logbook.
- 8. Make the original fuel tanks that were removed from the aircraft safe for shipping and return them to Cub Crafters, Inc. Instruction for the return shipment of the tanks that were removed will be provided with the new set of tanks
